OPTION 2: Full Time Year-Round School Enrollment

We are pleased to offer a discounted full time (year-round) tuition payment option. You may opt to pay a flat monthly rate (12 months) that will include the following services:

- Preschool tuition
- Full extended hours for the school-year, 7:30am 5:30pm (in accordance with school calendar)
- Day before Thanksgiving program
- Winter and Spring Camps (including extended hours, 7:30am 5:30pm)
- Summer Camp (10 weeks)
- Full extended hours for the full duration of Summer Camp, 7:30am 5:30pm

The full time schedule will commence at the start of the upcoming Summer Camp, on June 17, 2019, and conclude at the end of the upcoming school-year, on June 5, 2020.

Class Placement

Students will be assigned to a program based on age cut off dates that are set by the California Board of Education for public school entry. By following this standard, all the children in the class will be eligible to enter kindergarten together. We have found that children who graduate from our ECC and then join in synagogue and community activities together are able to maintain the close bonds which were formed during their early education years. Beth Am ECC strives to foster these relationships whenever possible. Students will be assigned to a class based on date of birth. Additional consideration will be given to gender balancing, days enrolled or formal professional developmental evaluations.

Enrollment Deposit and Full Tuition Guidelines

Please complete, initial, sign and return the four-page Enrollment Application with a \$500 non-refundable payment (\$450 for early bird registration by January 18, 2019, \$400 deposit and \$100/\$50 application fee). If you choose to return your application via email, a spot will only be held for you once your deposit check is received by the ECC office. \$400 of the application fee will be applied towards your tuition balance. An annual security fee of \$175/CBA members or \$575/non-members is charged to each ECC family. Please note these amounts may change modestly after the CBA annual meeting in May.

By signing the Enrollment Application, you legally obligate yourself for the FULL tuition amount on March 1, 2019 (March 29, 2019 for Gesher), even if you withdraw your child(ren) before the first day of summer camp/school. The ECC's expenses are incurred on an annual basis; therefore, the ECC is unable to refund tuition fees or forgive unpaid obligations if you choose to withdraw your child after March 1, 2019 (March 29, 2019 for Gesher). In accepting your Enrollment Application, the ECC assumes expenses that are not reduced if your child is withdrawn at a later date. Therefore, Congregation Beth Am will not refund any tuition fees paid, or cancel any unpaid obligations after March 1, 2019 (March 29, 2019 for Gesher). Your financial obligation to the ECC is for the FULL tuition amount as stated in this letter. In order to withdraw your child's enrollment you must contact the ECC office in writing by March 1, 2019 (March 29, 2019 for Gesher). A student's enrollment in the ECC is conditional upon current and timely payment of all tuition and membership fees (where applicable).
